



Report on Two Days Internal Assessors' Training on National Quality Assurance Standards (NQAS)

A. Introduction and Background

The National Quality Assurance Standards (NQAS) were introduced with the aim of enhancing the quality of care (QoC) provided in public health facilities. Initially, these standards were launched for District Hospitals in 2013. In 2014, the standards were extended to include Community Health Centres (functioning as FRUs) and Primary Health Centres with beds. Subsequently, in 2016, Quality Standards were established for Urban Primary Health Centres (PHCs), and further in 2021, Quality Standards were developed for Health & Wellness Centres – Sub Centres. NQAS Standards earned international recognition and accreditation from the International Society for Quality in Healthcare (ISQua). At the National level, the Insurance Regulatory and Development Authority (IRDA) recognized and endorsed these standards for hospital empanelment.

The implementation of National Quality Assurance Programmer's (NQAP) across all states has been closely monitored and supported by National Health System Resource Centre (NHSRC) since its launch in November 2013. In each state, a dedicated pool of assessors has been established to undertake assessment of public healthcare facilities, identify deficiencies, analyze these gaps, prioritize them, and create action plans for addressing these shortcomings. This comprehensive process is geared towards elevating the quality of services provided in our public healthcare institutions, ultimately working towards achieving National Certification.

The Department of Hospital Administration, AIIMS Bhubaneshwar, in collaboration with Department of Health & Family Welfare, Govt. of Odisha, NHM Odisha, UNICEF and with the technical support of Regional Resource Centre for Northeast States (Branch of NHSRC) organized a two-days training event designed for individuals who would serve as Internal Assessors. The primary objective of this training was to expand the pool of assessors capable of contributing to the NQAP implementation. RRC-NE played a supportive role in this initiative by formulating the training agenda, providing study materials, and conducting training sessions.

The training program encompassed 16 topics and included practical exercises, offering participants hands-on experience with various assessment methodologies. After the training sessions, there was an insightful discussion about the status of NQAS implementation in the state of Odisha by the State QA Consultant, Odisha, and the training concluded with a comprehensive post-training evaluation.

B. Objectives and Participants.

The main objectives of the training were as follow:

- 1. To impart understanding of the basic concept of Quality Assurance Standards and how to implement them in public health facilities.
- 2. To acquaint the participants with Area of Concerns, Standards, Measurable elements, Departmental Checklists and Scoring System.
- 3. To support the facilities for achieving National Quality Certification.

C. Inaugural Session

Furthermore, Dr Srivastava highlighted that in the same context, the National Quality Assurance Services (NQAS) were formulated and launched in the year 2013.

Prof (Dr) Ashutosh Biswas, Executive Director, AIIMS, BBSR, stated that the National Quality Assurance Standards provide the most accepted framework for assessing and assuring quality in public health care facilities in States and UT's.

Prof (Dr) Dilip Kumar Parida, Medical Superintendent, AIIMS Bhubaneswar informed that the goal of this training is to raise the number of qualified Quality professionals in the state of Odisha. These professionals will aid States/UTs in implementing National Quality Assurance Standards by way of mentoring/ supporting health facilities of Odisha and coordinating the efforts to achieve quality certification in accordance with the NHM Target.

Dr Dinabandhu Sahoo, Team Leader, SHSRC, NHM Odisha highlighted the expected outcome of this training program.

During this session, he provided a comprehensive breakdown of the services and facilities available within a hospital across various departments, including support services. Dr. Arya elucidated how compliance with standards and measurable elements is assessed, emphasizing that this assessment involves observations regarding the extent of service delivery, document reviews, and an evaluation of the utilization of these services.
Standards for Patient Rights (AOC B)	Dr. Manoranjan Mohapatra, State Consultant for Quality Assurance, delivered a comprehensive presentation on Patient Rights. This encompassed patients' entitlements to information about available services, accessibility, the assurance of being treated with dignity and confidentiality, as well as the elimination of any physical or financial barriers. Additionally, the session addressed patients' rights to make informed decisions regarding their treatment plans.
Standards for Inputs (AOC C)	Dr. Anup Basistha provided an elucidation regarding Area of Concern C, along with its seven accompanying standards covering infrastructure and its safety, Trained & competent Human Resource, availability of drugs, consumables, equipment's & instruments. This area primarily focuses on the structural aspects of healthcare facilities, adhering to the

He provided a comprehensive explanation of "Gap Analysis," employing techniques like the "fishbone diagram" and the "whywhy" technique, complete Furthermore, he illuminated the Risk Management framework and its implementation, followed by a concise overview of Clinical Governance and various audit processes.
KPI, Outcome & Patient Satisfaction Score (AOC-H)	Dr. Ajay Arya took the session on Outcome indicators where four areas of measures for quality – Productivity, Efficiency, Clinical Care & Service Quality were briefed in terms of measurable indicators. Additionally, he elaborated on the essential documentation requirements for NQAS, LaQshya, and MusQan National-level assessment and certifications. Furthermore, he offered a brief overview of the certification process and the mandatory criteria for achieving NQAS National Certification.
Overview of Customization Checklists for State of Odisha	Dr. Manoranjan Mohapatra in his session discussed and offered the knowledge about the checklist of each department in a different level of health facility and sensitize them on using the customized checklist for NQAS assessment.
Post training evaluation	Following the conclusion of the technical sessions, an extensive post-training assessment was conducted using a multiple-choice question format. This evaluation served as a valuable tool to gauge the participants' understanding and retention of the training content and only those who successfully passed this post-training evaluation would be eligible for empanelment as NQAS Internal Assessors
